

**Supervision agreement for doctoral theses (Dr. rer. nat.)**

**For PhD students within CRC 1085 Higher Invariants**

For this purpose the signers of this document agree on the following:

- (1) The doctoral student applies – within six months after having signed this document – for admission as a doctoral student of the Department of Mathematics (Zulassung zum Promotionsstudium). Currently, according to the regulations for the academic degree Doctor of Natural Sciences (Dr. rer. nat.) at the University of Regensburg, dated June 2nd, 2022), the committee in charge of this is the „Promotionskommission“
- (2) The student and the supervisors communicate regularly about the progress and intermediate steps of the thesis.
- (3) In the course of the doctoral thesis, the doctoral student is required to fulfill the following additional requirements

- (5) The supervisors are obliged to provide regular supervision. They control the progress of the work and support the doctoral student on her/his way towards scientific independence, and they advise in matters of career development.
- (6) The PhD student is integrated into the structures of the CRC 1085 Higher Invariants. The doctoral student is provided with a workplace at the University of Regensburg during the employment by the CRC, including computers and library access.
- (7) Before handing in the PhD thesis at the administration of the department (Antrag auf Zulassung zur Promotion gemäß §8 der Promotionsordnung), the doctoral student should have presented his PhD project in one of the working seminars of the department or in a colloquium talk.
- (8) Based on the individual needs of the doctoral student the supervisors implement the measures to combine family life and scientific work, according to the policies of the department and of the above named research structure(s).
- (9) This supervision agreement is valid as long as the doctoral student is accepted as a doctoral student of the department. It is not limited to the time of being employed as a doctoral student (including grants or other types of financial remuneration). The agreement also remains valid in case one of supervisor leaves from the university of Regensburg, unless this agreement is replaced by another equivalent agreement.
- (10)The signers of this document confirm that they will respect all standards of good scientific practice.
